## AMAN SABHA (Activities and Resolutions of its Branches).

#### BADIN.

An Aman Sabha meeting was held at Badin on Wednesday (24.5.22) when the well known Maulvi Abdul Aziz of "Hyderabad Latifi Madrassa" come down specially to exhort the people.

The Mukhtiarkar at the end announced the new peace terms offered to Turky which were received with rejoining. On the motion of Seth Virumal, which was seconded by Sahibdino samo, Syed Sidik Shah was unanimously elected President. Seth Dhamoomal was elected as Vice President and Seth Virumal as Secretary. After speechs, the meeting passed resolution condemning the acts of violence perpetrated in respect of life and property in various parts of India in consequence of the irresposible Non-co-operation and Khilafat agitators.

The meeting passed a resolution affirming their sincere loyalty to the king Emperor and prayed to the Alminghty to give long life and perosperity to King George the Fifth, and expressed satisfaction at the peace and justice, which were foundations of the benign British Government.

At a meeting of the "Aman Sabha" recently held at Berani, Taluka Shahdadpur, under the Chairmanship of K.B. He was decorated with "lungis" by Pir Bachal Shah, Pir Alamshah, Mir Hamed Ali Talpur, Khair Mohammed Khan, and Seth Methusing. #### DERO MOHABAT.

#### APPENDIX

#### (Aman Sabha - its branches and their activities).

#### BADIN

One Sundary night a couple of non-co-operators had come from Hyderabad taking advantage of the Hela which is held every first honday of the Lunar month addressed a motley crowd and exhorted them to sever connection with the British Government in India. In their speeches facts were distorted gross exaggerations made, and an absolutely wrong impression created and a Moulvi who was over carried by his zeal. The people of this Taluka are peace loving and positivety dislike the presence of such agitators in their midst, as was evidenced by the difficulty these gentlemen experience in getting a lodging here.

To counteract the effect of these discontentmongers a number of influential Zamindars and merchants of all casts met at Syed Nabi Bux Shah's residence and after a speech from Syed Nabi Bux Shah formed and strong Committee for the purpose of opposing the Non-co-operation movement in Badin Taluka. Syed Nabi Bux Shah who is a member of the Legislative Council of Bombay was unanimously elected president and Messrs Haji Khamaludin and Diwan Dingomal Bhopatrai were likewise elected Vice-President and Secretary, respectively. The Committee resolved to call a public meeting (in which Zamindars and haris are expected to muster strong on Thursday, where the audience will be addressed by some of the members and a few others.

(D.G. 19 May, 1921, p-5).

At Badin a meeting was called by the Secretary of the Anti-Non-Co-operation Association in order to obtain support in the small villages in the suburbs of Badin taluka to counteract Non-co-operation. At the successful gethering the keen spotaneous interest of the public was clearly seen.

Pir Mian Bhalan Shah Sahib said, "We agree fully with the work of this Committee and we are also of the opinion that it exists for the welfare of the country and we consider it our bounden duty to make it success. I was on tour in Karachi district and having heard of the Non-Co-operation meeting to be held here we made haste to put a stop to it and succeeded in our object."

Diwan Mulchand said, "We are very glad to have amongst us the staunch co-operators with the Government which have shown great sympathy to wards the Committee. We are prepared

to eradicate the baneful influences of the Non-Co-operators. We shall stand by the Government and help them in the Administration of the country."

Mr.Dingomal Bhopatrai a Zamindar of Badin said, "We should help the Government at all costs and must remain faithfull to it at all times." During the course of his speech he enquired into recent happenings in the Central Provinces and Chittagong. He was of the opinion that a wave of Bolshevism has swept anlong here thanks to these enemies of the Government. He also pointedout that the procedure and doctrine of Non-Co-operation was greatly detrimental to the public and especially to the Zamindars. He appreciated and clearly explained the good work and wise steps taken by the Government in the matter of the poligrimage "Haj".

Khan Sahib Sayyed Ali Bux Shah said," We hope that this Committee will gather strength day by day and that peace and order will be restored by putting down the Non-co-operation movement."

Seth Assandas - a well known Zamindar and merchant of Badin said," We fully believe in the public interests arising from such a gathering as this. We expect strong supporters from the public on this side of the country."

The President in closing the meeting said, "We should be faithful to the British Government and should help it in all ways."

He told the audience both Hindus and Muhammadans that they should unitedly condemn the actions of the youths in their taluka who had plunged headlong in the recent non-co-operation movement and they should for their part put forth every effort to rootout the mischief and to this end should make necessary arrangements. They were all loyal to the benign British Government under whose shadow they were happy and enjoyed freedom.

Munshi Mahomed Zakar delivered a lengthy speech in which he denounced the non-co-operation movement and spoke in praise of the benefits of the British rule and expressed the general sense of the loyalty of the People. He said that the non-co-operation movement was purely a selfish and most emproper movement. It was their bounden duty as subjects of His Majesty the King Emperor to maintain their sincere loyalty under whose rule they enjoyed every kind of freedom and were happy. They were indebted to the Government which had safeguarded their religious and temporal interests. The Holy Koran, had a reference to the effect that the subjects should maintain strict obedience to the King, and it was a great sin to start any movement against the King. They should always remain faithful and loyal to the Crown. It was a calculated lie of the Swarj fanatices who generally proclaimed that they had girded their loins in order to win freedom fox the people. The movement started by them had its roots in selfishness and it was evidently their cherished desire to secure the reins of government in their own hands which promoted, selfishness. It was a great sin to participate in the movement.

Speeches were also made by Din Mahomed Khan, retired Sub-Inspector, Abdul Hamid Khan, Pathan Zamindar and Honorary Magistrate Old Sukkur and by Mukhi Khushomal of Dahirki and many other Mukhis of different Panchayats demouncing the non-co-operation movement and expressing their loyalty to the Crown. A resolution affirming the sincere loyalty of the people was unanimously carried. The meeting also passed a resolution expressing their deep sense of sorrow at the death of Mrs. J.L.Rieu wife of the Commissioner-in-Sind and resolved to communicate the same to the Commissioner.

#### MANJHAND

With a view to combating the Non-co-operation movement and to enlighten the people and promote the best interests of the people an Aman Sabha (Peace organization) has been formed at Manjhand in the Karachi District, with Wadero Allahdino Khan Zamindar as Chairman and Seth Tahilram Pursumal, merchant and municipal Councillor, as Secretary. The Sabha organized a public meeting at which Hindus and Muhammadans numbering about 300 were present. The President in his speech expressed satisfaction at the firm loyalty of the people of Majhand and the neighbouring villages of the Mabal and said that Manjhand was free from the pernicious effect of the Khilafat and Non-co-operation movements. He spoke in praise of the benefits of the British rule and said that they emjoyed liberty and were happy and content. He called upon the audience to keep a loof from the Khilafat movement and asked them not to countenance or assist any non-co-operator. He stated that the chief object of the Aman Sabha was to contradict the false and malicious rumours generally spread by the opponents. It was their duty to see that they did not entertain the non-co-operation agitators if they happened to come there to spread the anarchical doctrine of Non-co-operation. They should put forth every effort to counter act the efforts of the agitators.

Seth Tejumal Khanchand said that they should at all times maintain their implicit loyalty to the British Government under whose shadows they always enjoyed the safety of life and prosperity. It was imperative that they should put forth strenous efforts to enlighten the uneducated country folk with regard to the evils arising in consequence of the Non-co-operation movement and thus save them from the clutches of Non-co-operators speeches were also made by others who all denounced the Non-co-operation movement and the meeting terminated after the singing of the National Anthem by the School boys.

TANDO BAGO

The Anti-non-co-operation movement is speedly gaining ground throughout Sind Reports of the Springing up of various Sabhas or organisations to counteract the mischievous effects of the Non-co-operation movement are coming from various parts of Sind (writes a correspondent). Last week a meeting of a peace and progress sabha under the Presidency of Khan-Bahadur Ghulam Mahomed Khan was hled at Tando Bago, which was attended by about 400 persons. K. S.Syed Ali Bux Shah was elected as Vice-President and Mr.Chuharmal Partabrai Zamindar as Secretary. Nineteen Zamindars and merchants were enrolled as members of the Sabha. The President Mir Ghulam Mahomed Khan in a sensible

speech said: The Government of India in the year 1919-20 spent 9 lakhs of rupees for the fares of Hajis and even during the time of the War allowed two of its steamers for the benefit of the Hajis. It has made much convenience and improvement in Kawran. It has made arrangements for the lodging of 3000 more Hajis. At Beran twon they have built a big camping ground at a cost of Rs.25,000 for the Hajis with the sole object of decreasing the inconvenience of Hajis at Kawran. In 1920-21 the Government of India sanctioned 10 lakhs of rupees for providing facilities and convenience for Hajis. At Jeddah a big, hospital has been opened by them for the accomodation of 400 Haji patients. Free return tickets has been provided by the Indian Government to very poor and helpless Hajis, who have been sent to their homes. It has provided several facilities for the hindus also from time to time. Why should we then be against such a just Government? I appeal to all present to maintain co-operation with the Government in all directions. Mr. Chuharmal Secretary then spoke for about half an hour, in which he dwelt upon the loyalty of the people and the extended rights of the people in the new enlarged councils and peace and security of life and property enjoyed by the people under the benign British Government. He further said that Government was doing its utmost for the people; that Government did not interfere in the least if any person refrained from drinking or were Indian made cloth. Government did not enterfere with the religious views of the people. Government did not prevent any Hindu embracing the Islam faithf or any Christian from taking to the Hindu or the Muhammadan faith.

#### TANDO JAM

The Anti-non-co-operation movement is making remarkable progress throughout the province. Reports of the formation of Societies and organisations for the purpose of counter-acting the mischievous and dangerous propaganda of Non-co-operation are reading daily from various quarters. These societies are endeavouring as best as possible to educate the poor and easily gullible portion of the public who are generally led astray by the non-co-operators who employ all sorts of means to appeal to their ignorance and passion and thus fill their own ranks.

Last week a public meeting was organized by the Aman Sabha (Peace organization) of Tando Jam with the object of explaining the objects of the Aman Sabha and also to expose the evits and the darkside of the Non-co-operation movement. About three or four hundred people attended the meeting besides a dozen Non-co-operators. The president Bahi Kissumal, told the audience that the Aman Sabha was started with a view to
